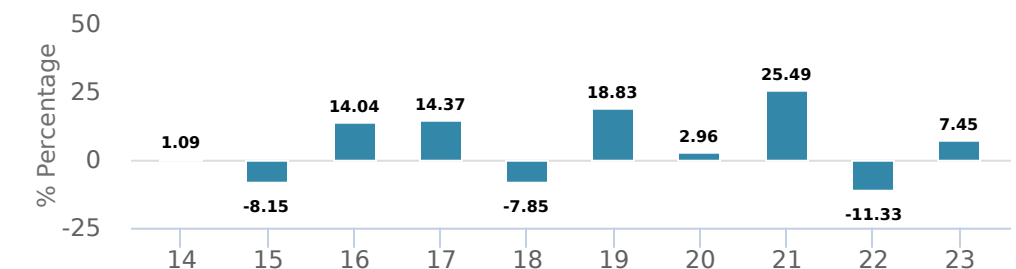

Average annual compound returns

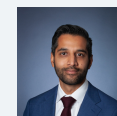
