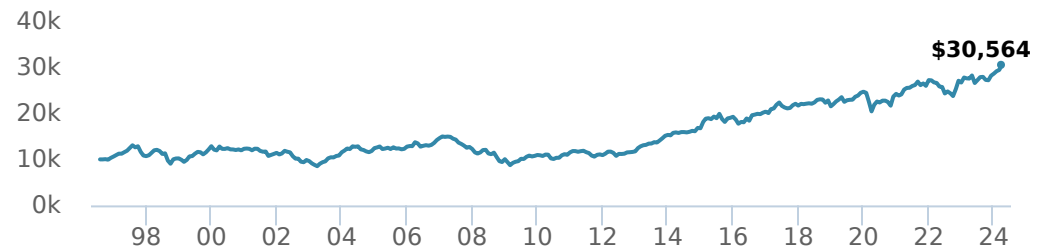

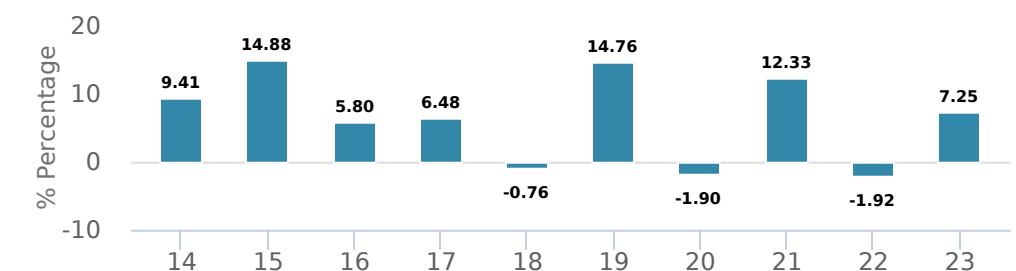

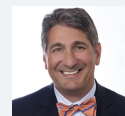
MANAGEMENT TEAM
