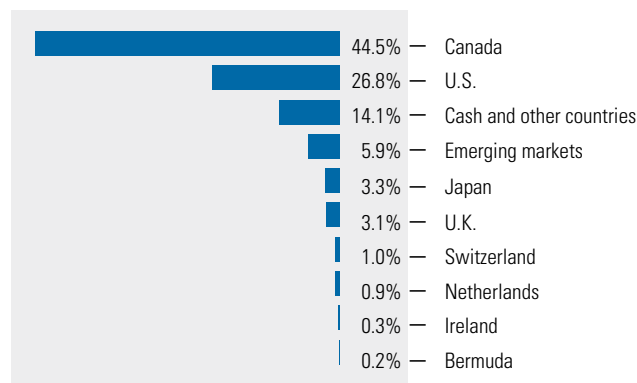

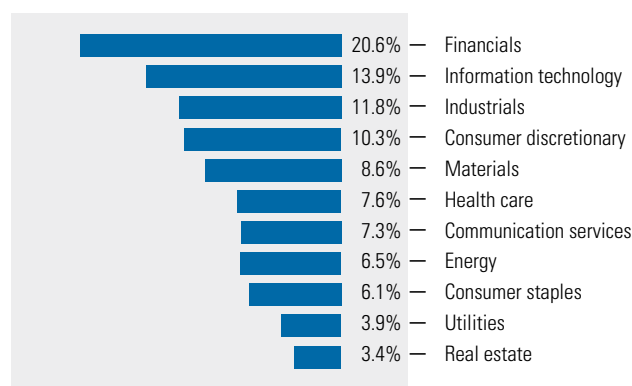
Geographic Regions



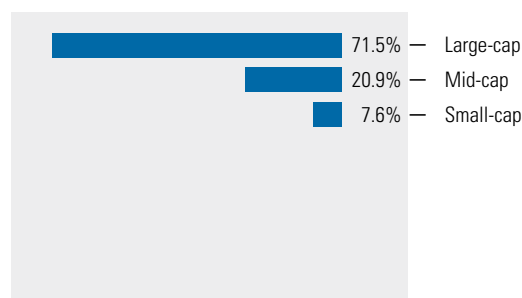
