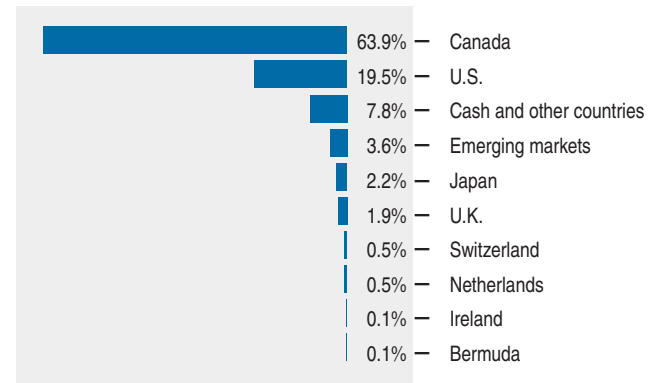

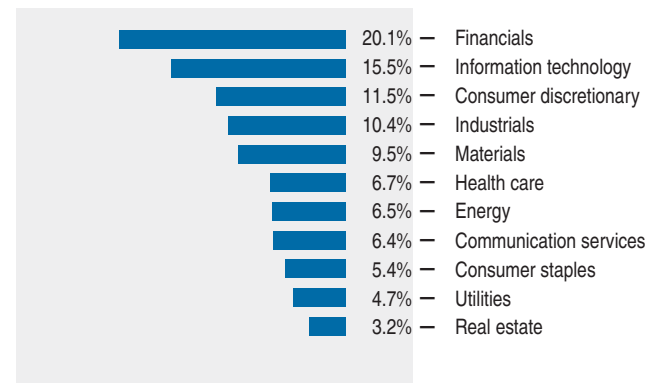
Geographic Regions



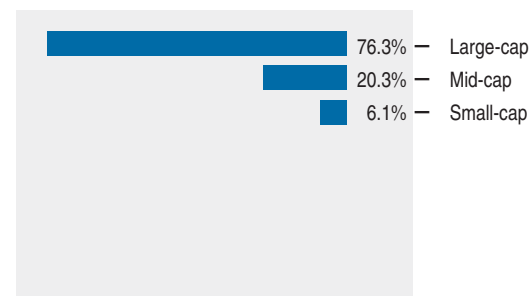
