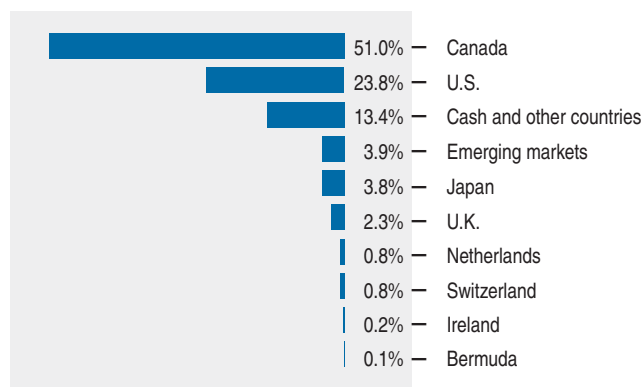

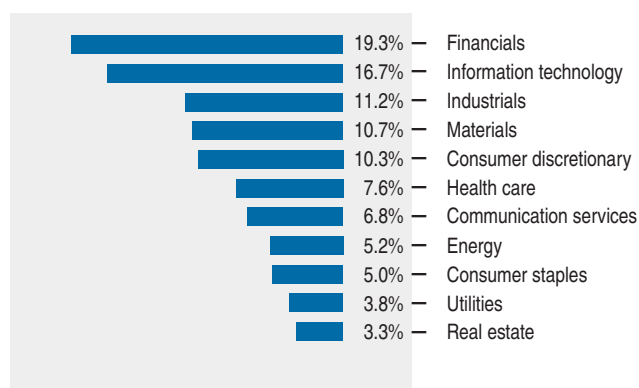
Geographic Regions



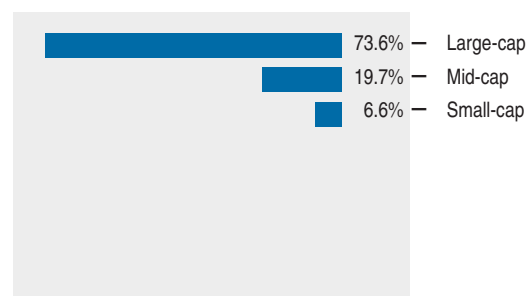
