Further, at the special meeting of securityholders of Sentry Canadian Resource Class, securityholders will consider the proposal to change the investment objective of the Fund, effectively on or about May 3, 2018, to allow the Fund to invest primarily in equity securities of companies involved in the energy and natural resources sector located anywhere in the world.
